MCA Balanced 2 Stars - US Balanced Universe
[2-Star Category:] had one of the top ten returns for the one-year period in their respective universes.
MCA Conservative 1 Stars - US Balanced Universe
[1-Star Category:] had one of the top ten returns for the quarter in their respective universe.
MCA Conservative 2 Stars - US Balanced Universe
[2-Star Category:] had one of the top ten returns for the one-year period in their respective universe.

A description of each category is listed below:

[I-Star Category:] had one of the top ten returns for the quarter in their respective universe.

[2-Star Category:] had one of the top ten returns for the one-year period in their respective universes.

[3-Star Category:] had one of the top ten returns for the three-year period in their respective universes

[4-Star Category:] had an r-squared of 0.80 or greater relative to the style benchmark for the recent five-year period. Moreover, returns must have exceeded the appropriate style benchmark for the three latest three-year rolling periods. The top ten returns for the latest three-year period then become the 4 Star Top Guns.

[Bull & Bear Masters:] had an r-squared of 0.80 or greater relative to the style benchmark for a threeyear period. Moreover, products must have an upside market capture over 100 and a downside market capture less than 100 relative to the style benchmark. The top ten ratios of Upside Capture Ratio over Downside Capture Ratio become the PSN Bull & Bear Masters.

Through a combination of Informa Financial Intelligence's proprietary performance screens, \*<u>PSN Top</u> <u>Guns</u> (\*free registration to view Top Guns) ranks products in six proprietary categories in over 50 universes. This is a well-respected quarterly ranking and is widely used by institutional asset managers and investors.
